The Mississippi River Basin is the most important food-producing river basin in the world supplementing the diet of 1 in every 12 people across the globe. Mounting climate risk is compromising the ability of watersheds around the world to provide the most critical staples of life—food and fresh water. Free and equitable access to water is essential not only for the drinking supply but also to power the major economies of cities including manufacturing and agriculture.

Because cities contain the most valuable built assets of national economies, cities can be the driving force to restore and sustain the most valuable natural assets that make possible the built ones. 102 U.S. cities have banded together to mitigate climate impacts at a new level of subnational cooperation sequestering over 166,000 tons of carbon in the near-term and 350,000 tons in the medium-term.
