

# **AMERICA IS ALL IN AT COP28**

## **EXECUTIVE SUMMARY**

America Is All In made a significant impact at the UN Climate Negotiations (COP28) in Dubai, United Arab Emirates, where the first Global Stocktake of the Paris Agreement was concluded. The coalition's wide-ranging presence at these critical talks included a robust U.S. subnational and non-federal delegation; a breakout session during the first ever Local Climate Action Summit for international mayors, governors, and other elected officials; an America Is All In Action Center event space and board room, which played host to two dozen different events; and a number of analytical deliverables, coalition member and partner progress markers, and public announcements that ensured the continued contributions and influence of U.S. communities, businesses, and institutions in delivering ambitious climate action with global impact.

Throughout COP28, All In members were able to showcase the substantive climate action happening at health care centers, universities, state and local governments, and businesses across the United States. All In members highlighted how impactful U.S. Federal leadership is through the Inflation Reduction Act and Bipartisan Infrastructure Law, which, coupled with subnational implementation, creates the foundation for U.S. delivery of our climate targets.

## STATEMENT FROM AMERICA IS ALL IN

## CO-CHAIRS MICHAEL BLOOMBERG, JAY INSLEE, LISA JACKSON, VI LYLES, AND GINA MCCARTHY

The UN Framework Convention on Climate Change (UNFCCC) 28th Conference of the Parties (COP28) provided a historic opportunity to recognize the critical role local leaders play in reducing emissions, addressing climate risk, and supercharging national efforts to move further and faster on climate progress. The Local Climate Action Summit (LCAS) brought together over 500 mayors, governors, and local leaders from over 60 countries across six continents in Dubai to accelerate multilevel climate action and, for the first time, integrated local climate leadership into the COP program and process. During LCAS and throughout COP28, America Is All In was held up as a model of how subnational partners can both lead in the absence of national climate action and also accelerate their progress when the partnership with the federal government is strong.

When the curtain fell on COP28, the global community came together to state clearly that fossil fuels and super pollutants like methane need to be eliminated, that the future will run on renewable power, and that economic development will grow based on clean technologies. The final COP28 agreement is not the end of our work, but an important market signal and the beginning of a new era of climate action. We have our marching orders: tripling global renewable energy capacity by 2030, more public and private sector investments in the developing world, halting deforestation and land degradation, and giving every country—especially those in the Global South—a chance to build stable, secure clean energy economies. We are encouraged by the importance the agreement places on the views and experience of non-state actors at the 'local, subnational, national and regional levels.' Throughout this critical decade for climate action, America Is All In will ensure that the international community continues to hear from U.S. cities, states, tribal nations, businesses, and institutions that are leading the climate fight in their communities to build a more equitable future for all people. We're eager to support the United States as it develops its 2035 climate goal, or national determined contribution to the Paris agreement.

## COALITION PRESENCE AT COP28

America Is All In managed and supported a strong cross constituency delegation of 175+ representatives, including over 20 U.S. mayors and city officials, a U.S. governor, a dozen state leaders, and dozens of civil society leaders—from cultural centers to health care systems and higher education. These representatives were joined by high ranking federal officials, members of Congress, and international subnational counterparts.

## AMERICA IS ALL IN AT THE LOCAL CLIMATE ACTION SUMMIT

America Is All In supported the historic Local Climate Action Summit, co-hosted by the COP28 Presidency and Bloomberg Philanthropies. Over 500 subnational leaders from 60 countries, including over 30 elected officials from the United States, came together to highlight how communities are at the cutting edge of climate action. UN Special Envoy Mike **Bloomberg** held up *America Is All In* as a model for success in plenary remarks in front of the UN Secretary General and COP28 President, Sultan Al Jaber.

At a U.S.-focused breakout session hosted by America Is All In, U.S. elected officials,

environmental justice leaders, and other subnational actors engaged federal experts on ways to improve federal and non-federal partnerships to enhance climate-smart implementation across energy systems, transportation, public health, workforce development, and more. At this event, All In Managing Co-Chair Gina McCarthy announced that America Is All In would lead a comprehensive stakeholder engagement process to bring subnational experience and voices into the next U.S. climate strategy update (see more below). White House Senior Advisor John Podesta and U.S. Special Representative for City and State Diplomacy Ambassador Nina Hachigan were among the federal officials to provide remarks and perspectives.

## AMERICA IS ALL IN ACTION CENTER PROGRAMMING HIGHLIGHTS

The America Is All In Action Center featured nearly 20 public events (streamed live), a handful of roundtable discussions, and two town halls for coalition members to engage high ranking U.S. federal officials, U.S. elected officials, corporate and financial institution partners, leaders in environmental justice, and more took the stage to highlight their climate leadership to an international audience, comparing experiences with fellow subnational partners from around the globe. Over 100 panelists drew an in-person crowd of 500+ attendees over the course of three days. The events have garnered a total of 1,351 views on the All In YouTube Channel as of December 19, 2023. - Ali Zaidi, White House National Climate Advisor, met with All In coalition members and U.S.-based practitioners in a closed-door town hall. The focus was on evaluating the progress of the IRA, acknowledging challenges, and highlighting positive climate investments in All In member communities. In a separate town hall, Carlos Monje, Under Secretary of Transportation for Policy at the U.S. Department of Transportation (DOT), discussed the positive impacts of climate investment in the transportation sector.
- Peggy Shepard, Co-Founder and Executive Director of WE ACT, and Dr. Robert Bullard, Founder of the Bullard Center for Environmental and Climate Justice, delved into opportunities and challenges for key initiatives like the IRA, BIL, and Justice 40.
- A public health-focused session, in partnership with the Center for Global Sustainability, included the launch of an All In report focused on improved air quality & health benefits. Panelists included Shelly Schlenker, Chief Advocacy Officer at Commonspirit Health, and Liane Randolph, Chair of the California Air Resources Board, who explored the crucial role of decarbonization in reducing pollution and promoting health equity.
- Financial institutions representing market leaders like **Karen Fang**, Bank of America, and **Ivan Frishberg**, Amalgamated Bank, joined community partners like Harold Pettigrew, Opportunity Finance Network and Dan Stiles, Coalition for Green Capital to discuss with Ethan Zindler, U.S. Treasury, how to finance the transition using a variety of financing tools at these various institutions while relying on the support of the U.S. Federal Government.
- The U.S. Climate Alliance co-hosted an event in which they released their annual report and addressed nationwide climate challenges, with leaders like Governor Michelle Lujan Grisham of New Mexico; David Hochschild, Chair of the California Energy Commission; Serena McIlwain, Secretary of the Maryland Department of the Environment; and James Kenney, Secretary of the New Mexico Environment Department.
- The U.S. Conference of Mayors co-hosted an event that addressed the current challenges and opportunities faced by mayors in protecting their citizens, especially vulnerable populations, amid increasingly drastic weather patterns. Mayors Andy Ginther of Columbus, OH; LaToya Cantrell of New Orleans, LA; Frank Cownie of Des Moines, IA; Barbara Buffaloe of Columbia, MO; and Elizabeth Kautz of Burnsville, MN discussed their strategies for utilizing programs like IRA and BIL and innovative financing solutions to support their climate action plans.

## **ALL IN ANNOUNCEMENTS AND DELIVERABLES**

All In members and partners made a number of announcements and delivered new reports highlighting the impact of subnational U.S. climate leadership. Here are just a few of those announcements:

America Is All In released a new report showing that an all-in climate strategy will improve air quality in all 50 states. This report, from the Center for Global Sustainability at the University of Maryland, demonstrates that an all-of-society approach to achieving U.S. climate goals—integrating federal policies from Congress and the Executive Branches with actions from states, cities, businesses, and communities—can realize improved air quality and health benefits across every state and in nearly every county in the United States. The report found that cutting emissions by at least 50% by 2030 will prevent 5,400 annual deaths in 2030, and 63,600 deaths between 2024 to 2035.

- America Is All In announced that it will develop a comprehensive stakeholder engagement process to provide subnational feedback to the U.S. Federal Government on its updated Nationally Determined Contribution (NDC), required as part of the Paris Agreement. America Is All In will bring together subnational partners that are committed to a net-zero transition to identify practical solutions on each of the NDC sectors. America Is All In is the most expansive coalition of leaders ever assembled in support of climate action in the United States, representing 50 states, 65 percent of the U.S. population and 68 percent of U.S. GDP, and it is well placed to bring together diverse voices to support a comprehensive approach to climate action for the U.S. economy.
- America is All in announced the coalition's alignment with the overarching goals of the Fossil to Clean campaign. The campaign is focused on aggressive build-out of clean solutions, policy reform, and collective effort toward a just and equitable transition, which are all core goals of the America Is All In coalition. All In members who have chosen to formally sign on to the campaign include Atlassian, Avocado Green Mattress, Change Finance, PBC, Climate Positive Consulting, Danone, eBay, ECOS, EILEEN FISHER, Inc., ENSO, Geelen Counterflow, Hewlett Packard Enterprise, IKEA, JLL, Nestlé, Novozymes, OLIPOP, Patagonia, Sense-Lab, Signify, Sony Group Corporation, Trane Technologies, and Unilever.
- Mississippi River Cities & Towns Initiative (MRCTI) mayors announced 100,000 acres supported by climate projects along the Mississippi River. The MRCTI mayors also signed an agreement with Indian River Cities, forming the first international collaboration between river city mayors between the U.S. and India.
- Boise, Idaho announced that the city implemented its new Modern Zoning Code to ensure the city's future design and development protects the character it loves and creates more walkable, dynamic spaces for everyone. In addition, the city has launched a new Development Tracker to ensure residents can easily access information on what types of projects are happening in the city.
- The **U.S. Climate Alliance** released their annual report featuring new analysis indicating that its 25 member states and territories, accounting for 60% of the U.S. economy and 55% of the population, are projected to achieve a remarkable 26% reduction in greenhouse gas emissions by 2025 below 2005 levels.
- America Is All In member CommonSpirit Health is accelerating towards its net zero goal by 2040 through the deployment of the Virtually Integrated Care (VIC) Model. By May 2024, virtual nursing capacities will be established in 11 locations, adding 720 beds to enhance patient care, address workforce shortages, and reduce transportation and greenhouse gas burdens. Their vision for FY 2025 involves expanding VIC beyond units to entire hospitals across five regions, potentially incorporating 50 more hospitals annually.
- Metrus Energy announced that it is doubling its investment commitment under America Is All In to an impressive \$400 million, up from the initial \$200 million. This significant increase will be officially announced as part of Metrus' pledge under Mission Efficiency. Additionally, Metrus Energy is proud to declare its commitment to the Global Cooling Pledge.
- At COP28, the Association of Science and Technology Centers, representing over 600 member organizations globally, unveiled its Seeding Action initiative through its new public engagement effort. Seeding Action aims to address a crucial missing ingredient for large-scale climate action—widespread public action and demand for corporate, government, and institutional changes.
- America Is All In, as the preeminent U.S. subnational climate coalition, acted as a model and succeeded in working with the U.S. Federal government to pledge to join the Coalition for High Ambition Multilevel Partnerships, or CHAMP, alongside 70 additional countries.
- CDP released their 2023 Global Infrastructure Snapshot—the largest repository of pending urban climate-related project data. Based on data provided by over 1,000 cities reporting through CDP-ICLEI Track in 2023, the Snapshot identifies 2,346 climate-related infrastructure projects reported by 636 cities across 86 countries. These projects are worth over \$146 billion and seeking over \$65 billion in investment.
